House rules.

## 1. Conditions of entrance

Everyone who wants to visit the campsite or spend the night, should present itself in advance in the reception. The fact that you stay on the campsite, means you respect and apply our house rules.

2. FORMALITIES

Everyone who wants to stay at least one night on the campsite, should present itself to the campsite staff with valid identity cards and fill in the forms proposed by the staff.

3. SET UP

The camping equipment must be set up on the place, designated by the staff, following the directions of the staff. The client should park his vehicle on the pitch/parcel or on the parking near the entrance of the site. It is not allowed to park a vehicle on an empty pitch.

4. RECEPTION

In the reception you'll find information about the campsite facilities, facilities in the neighborhood, touristic information and other addresses that can be of use for you.

5. PRICES

You pay at the reception. The prices are listed on a board near the entrance of the campsite and in the reception. The price depends on how many nights you stay on the campsite and which services you choose.

6. NOISE NUICANCE AND CALM

The campers are requested to avoid any kind of hard noise or loud conversations, that could disturb other campers. Music devices or speakers should be adjusted to a correct volume. The closing of doors and car trunks must happen as discrete as possible. Between 11.00 pm and 07.00 there should be complete silence on the property (on animation evenings 11.30 pm).

7. VISITORS

After permission of the staff, clients are allowed to receive visitors. The visitors will be under responsibility of the client. The client receives his visitors at the entrance of the property. If the visitors wish to spend a night on the campsite, a contribution between  $4 \in$  and  $6 \in$  + tourist taxes per visitor per night will be asked. Visitors can't park their car on the property and must park their car obligatory on the parking next to the entrance.

8. TRAFFIC AND PARKING

On the property the maximum speed limit is 10 km/h. No traffic between 10.30 pm and 07.30 am is allowed on the site (this also concerns electric cars and motors). Vehicle shouldn't block traffic or disturb the setup of new clients. It's strictly forbidden to charge electric or hybrid vehicle's on the pitches or near the accommodations.

When a client wishes to leave before the opening hours of the barrier, he should park his car on the parking next to the campsite entrance. Clients are not allowed to open or close the barrier themselves.

## 9. MAINTENANCE AND APPEARANCE OF ALL INSTALLATIONS

Everyone is expected to withheld itself from every possible action that may damage the cleanness, hygiene or the aspect of the property and it's facilities. It's forbidden to throw to dump sewage on property. Sewage must dispose their sewage on the designated place. All trash should be disposed in the designated trashcans. Washing is only allowed in the designated sinks. Plants and trees should be respected. A client can't put nails in the trees, break off tree branches or remove plants. Clients are not allowed to fence off their pitches or

to dig holes in the ground. Every damage done to the vegetation, the fences, the property or the campsite facilities, will be charged on the client. The accommodation or pitch, should be just as proper and clean when the client leaves, as when he arrives.

10. SAFETY

Fire: open fire is strictly forbidden on the property. Barbecues etc should be well maintained, and can't be used in dangerous situations. In the case of a fire, warn the campsite staff immediately. There are fire extinguishers available on the property.

11. SPORT AND GAMES

Nearby buildings, pitches and accommodations, no violent or inconvenient games are allowed. Parents should watch their children.

## 12. VIOLATING THE HOUSERULES

In the case a client or one of the participants disturbs a stay of other guests won't comply the house rules, the campsite is entitled to call upon the client. In the case of severe or frequent violations, the campsite can interrupt the contract between the campsite and the client. In the case of a criminal violence, the campsite will warn the authorities.
